**Item 1.2 – DIVISIONS**

<b>1.2.1</b>	The divisions for the 2025 Junior State Cup – North (JSCN) will be: <ul style="list-style-type: none"> <li>• <b>BOYS:</b> Under 10 Challenge (Div A) and Development (Div B) divisions, Under 12 Challenge (Div A) and Development (Div B) divisions (Affiliates/Clubs)</li> <li>• <b>BOYS:</b> Under 14, Under 16 and Under 18 (Affiliates only)</li> <li>• <b>GIRLS:</b> Under 10 Challenge (Div A) and Development (Div B) divisions, Under 12 Challenge (Div A) and Development (Div B) divisions (Affiliates/Clubs)</li> <li>a- <b>GIRLS:</b> Under 14, Under 16 and Under 18 (Affiliates only)</li> </ul>
<b>1.2.2</b>	<ul style="list-style-type: none"> <li>• Divisions will be reviewed and confirmed once entries have closed.</li> <li>• A minimum of four (4) teams are required to deem a division viable. If there are three (3) or less teams nominated, then those teams will be invited to join with the next closest division as determined by NQ.</li> <li>• If a team(s) withdraws after the close of nominations causing a viable division to become unviable, the division may still go ahead under a different format at NQ’s discretion.</li> </ul>
<b>1.2.3</b>	Affiliate team managers/coaches are to nominate their team in the correct division on the online registration system
<b>1.2.4</b>	Teams nominated for Development divisions will be reviewed and confirmed once entries have closed. NQ will have full discretion to accept a team into either Challenge or Development Divisions.
<b>1.2.5</b>	<ul style="list-style-type: none"> <li>• The U10s/U12s Development divisions aim to foster the development of players, without a win at all cost mentality, promoting fun, enjoyable and positive experiences for developing players of all abilities.</li> <li>• There will be <b>NO</b> finals, ladders, or medals in Development divisions. will not go through to a final series and will only finish with ladder placings as this division has been created to focus on development and enjoying the sport of touch.</li> <li>• NQ may move an Affiliate team(s) between divisions as necessary.</li> </ul>



- NQ reserves the right of final decision for the inclusion/exclusion of Affiliate team in either division, based on draw requirements and any other competition considerations.
- The U14, U16 and U18 divisions will only have one Challenge division.

**Item 1.3 – TEAM AND MATCH OFFICIALS REGISTRATION**

**1.3.1** Team & Match Officials Nominations will be available through the link provided to Affiliate/Club Coordinators.

**Team and Referee Nominations Open 10/02/2005**

- Affiliates/Clubs are required to nominate **one (1)** Referee per nominated team.
- Nominated Referees must be of the required standard and qualification (Section 2.6).
- Nominated Referees must be able to be in attendance for **all 3 days** of competition and attend all required Referee Meetings.

**Team and Referee Nominations Close 28/02/2025**

- Team Nominations will be deemed inactive and not confirmed until the required Referees are registered and all team nomination requirements outlined in Section 2.2.4 are met.
- The number of team nominations confirmed for an Affiliate/Club will only be equal to the number of registered referees.
- If an Affiliate has less referees registered than teams nominated, NQ will prioritize team nominations starting from youngest and lowest age groups first up to the oldest.
- No team nominations will be accepted after this date.

**Team Officials Registration**

- Team Officials registration links for all (Referees, Coaches and Managers) to register will be provided to Affiliate/Club coordinator and made live for all Team Officials to register once the Affiliate/Club has met **ALL** team nomination requirements.
- Match Officials Registration Fee: \$0.00

**Player Registration**

- Individual Player Registration Fee \$60 (GST Inclusive) per player (**if paid by 16/03/2025**).
- Individual Player registrations will open on **03/03/2025 or earlier**.
- Individual Player registration links will be made available to each team's Club/Affiliate coordinator and made live for players to register only once the Affiliate/Club has met **ALL** team nomination requirements.
- Individual Player Fees must be paid (in full) at the point of registration.

**Late Player Registrations**

The link for Player registrations will remain open up until 23 March 2025. However please note that any player registrations made after the initial close off date of 16/03/2025 will incur a late payment fee of \$15.00 per registration.



<p><b>1.3.2</b></p>	<p><b>Player/Officials/Team registrations – MySideline</b></p> <p>Once Team Nominations have been confirmed by NQ, the Affiliate/Club Coordinator will receive a link to the MySideline team player registrations and will also be provided with access into the back end of the Junior State Cup North MySideline System. This access will allow the Affiliate/Club Coordinators to manage teams, individual nominations and shirt number entry.</p> <p>There are several important details that are necessary for this process to be completed.</p> <ul style="list-style-type: none"> <li>› Number of Teams the Affiliate/Club is entering into the event (Schedule A only)</li> <li>› Qualified Match Officials for each team and details (Schedule B &amp; Online)</li> <li>› Affiliate/Club delegate acceptance form returned (Schedule C only)</li> <li>› Team Management details (Schedule D &amp; Online)</li> </ul>
<p><b>1.3.3</b></p>	<p><b>Affiliate/Club Coordinators</b></p> <p>There will be only one (1) point of contact per Affiliate/Club. The details of this person are to be completed on the ‘Schedule A Team Nomination Form’. Any documentation forwarded by anyone other than the Affiliate/Club Coordinator will be returned to the sender. This rule will also apply for the duration of the event, any communication with the NQ Admin Team must be done so through the Affiliate/Club Coordinator.</p>
<p><b>1.3.4</b></p>	<p>Teams will not be accepted into the JSCN draw unless all requirements in these conditions have been met and received by the NQ Touch office by the date specified.</p>
<p><b>1.3.5</b></p>	<p><b>Additional Players</b></p> <p>No players can be added or deleted from the team sheets once Affiliate/Club coordinators and/or Team Managers submit their final Team Sheets at Tournament check-in.</p>
<p><b>1.3.6</b></p>	<p><b>Suspended Player/Participant</b></p> <p>A player (or any other participant) who is serving a current suspension is <b>NOT ELIGIBLE</b> to enter a NQ event.</p>
<p><b>1.3.7</b></p>	<p><b>Exemption Request</b></p> <p>An Affiliate/Club may seek exemption from NQ, in writing, for a player who has not met the above eligibility criteria, through injury, illness or other exceptional circumstances. NQ, in its sole discretion, may approve or deny a request and will consider each request on a case-by-case basis. There is <u>no guarantee</u> that a request will be approved.</p> <p>Each Affiliate/Club is limited to a maximum of two (2) exemptions requests per team.</p>
<p><b>1.3.8</b></p>	<p>All players will agree upon registration to and agree to abide by:</p> <ul style="list-style-type: none"> <li>› JSCN Conditions of Entry</li> <li>› NQ Code of Behavior (Appendix 2)</li> <li>› TFA Member and Participant Declaration</li> <li>› TFA Code of Conduct</li> <li>› TFA Social Media Community Code</li> <li>› QTF Social Media Policy</li> <li>› QTF Child &amp; Youth Risk Management Strategy</li> </ul> <p>A copy of the above documents is attached to Appendixes</p>





**Item 1.4 – PROOF OF AGE/AGE QUALIFICATION**

**1.4.1** The birth dates for age divisions are:

<b>Under 18 Boys/ Girls</b>	Born in 2007	Born in 2008

NQ is committed to ensuring all Affiliates/Clubs have an equal opportunity to participate in the Junior State Cup North, while promoting long term athlete development and participation growth within each age group within Affiliates/Clubs.

NQ also recognizes smaller regional affiliates/clubs and at times relies on the selection of younger players to enable a team to be entered into competitions. Teams requiring younger players are to email the NQ office [admin@ngtouch.com.au](mailto:admin@ngtouch.com.au) for an approved exemption to a specific team.

**1.4.2** In case of any protest, query, or objection regarding the age of a player, by any team registered in this tournament, the Tour Manager/Team Manager/Coach of clubs/Affiliate participating must have readily available proof of age for all players in their teams. Only the following identifications will be accepted as proof of age:

- Birth Certificate
- School ID Card
- Passport
- Government-issued Proof of Age Card.

**1.4.3** The JSCN Tournament Committee reserves the right to request the record details from the Team Manager at any time throughout the duration of the tournament or after an official written complaint is received by the JSCN Tournament Director.  
If a Team Manager is unable to produce the record of details within 30 minutes of a request by the JSCN Tournament Committee, the player in question will not be permitted to take the field for any future games until valid proof of eligibility can be produced and is accepted by the JSCN Tournament Director.

**1.4.4** If an ineligible player is found to have played any games, the team may be disqualified from the Tournament. Any points won up until that time will be allocated to their opposition teams played against and the standings/table will be amended accordingly.

**Item 1.5 – TEAM MANAGEMENT ELIGIBILITY AND REGISTRATION**

**1.5.1** Team Management refers to Coaches and Team Managers.

**1.5.2** It is a requirement that each Affiliate/Club keeps adequate records of the following for all Team Management and Support Staff (Affiliate Coordinator, Medical, Media and any other adults working with children) at JSCN.

- **Team Coaches**
  - Coaching Accreditation
  - Working with Children ‘Blue Card’
- **Team Management & Support Staff**
  - Working with Children ‘Blue Card’





	The Affiliate/Club coordinator must ensure that all coaches, Team Management and Support Staff Blue Cards are linked to their organization.
<b>1.5.3</b>	All Coaches must have an active accreditation in the TFA “The Nest” for the accreditation of a minimum of a TFA Foundation Coach accreditation.
<b>1.5.4</b>	<p><b>Play by the Rules – Online Learning</b> Affiliate/Club coordinators and Team Management are also required to complete the following components from the Play by the Rules portal: <a href="http://www.playbytherules.net.au">www.playbytherules.net.au</a></p> <ul style="list-style-type: none"> <li>• <b>Harassment &amp; Discrimination:</b> Affiliate/Club Coordinator/Coach/Assistant Coach/Team Manager</li> <li>• <b>Complaints Handling:</b> Affiliate/Club coordinator <b>only</b></li> <li>• <b>Child Protection:</b> Affiliate/Club coordinator/Coach/Assistant Coach/Team Manager.</li> </ul> <p>Upon successful completion of the components, a certificate will be sent to the individual.</p> <p>It is the Affiliate/Club coordinator’s responsibility to ensure the above is completed by all who are required to. Once this is done the Affiliate/Club coordinator must send copies of <b>ALL</b> completed training modules by 23 March 2025.</p>

## SECTION 2: ENTRY REQUIREMENTS

### Item 2.1 – CONDITIONS OF ENTRY

<b>2.1.1</b>	<p>a- The Affiliate/Club Coordinator is required to sign off on the Acceptance of Conditions of Entry (Schedule C) and return to the NQTA Office with the Affiliate/Club Team Nomination Form (Schedule A) and the Qualified Match Officials form (Schedule B)</p> <p>b- An Affiliate/Club Coordinator is to ensure that they, all team coaches, and managers are aware of these conditions of entry that your Affiliate/club have accepted prior to the commencement of the championships.</p> <p>c- For issues not covered within these Conditions of Entry, please forward a request or queries in writing to the NQTA Operations Manager on email - <a href="mailto:admin@nqtouch.com.au">admin@nqtouch.com.au</a> by 4pm on the 28<sup>th</sup> February 2025.</p>

### Item 2.2 – TEAM ELIGIBILITY

<b>2.2.1</b>	To be eligible to participate at the JSCN, a team must be either: <ul style="list-style-type: none"> <li>a- A representative team from an Affiliate within Queensland</li> <li>b- A team from a club of an Affiliate within Queensland (U10 &amp; U12 only)</li> <li>c- Teams can be a combination of clubs from within an Affiliate (U10 &amp; U12 only) within Queensland.</li> <li>d- An invited team as approved by the JSCN Committee.</li> </ul>
<b>2.2.2</b>	All participating entities must be fully financial with Touch Football Australia and all affiliated local Affiliates/clubs must abide by the laws and by-laws of the NQTA and Touch Football Australia.
<b>2.2.3</b>	An Affiliate’s/Club’s team may <b>only</b> comprise players in line with Section 2.3.2 and competing in an eligible competition outlined in Section 2.3.7.
<b>2.2.4</b>	<p>Team Nomination Requirements:</p> <ul style="list-style-type: none"> <li>• Authorised Affiliate/Club Coordinator contact and details.</li> <li>• Teams the Affiliate/Club is entering into the event.</li> <li>• A qualified Referee, as outlined in Section 2.6, registered for each nominated team.</li> <li>• Team Coach and Manager details.</li> </ul> <p>No team will be accepted into the competition if the above is not met within the designated timeframes.</p>



**Item 2.3 – TEAM COMPOSITION AND PLAYER ELIGIBILITY - nominating teams and players must meet the following criteria:**

2.3.1	A maximum of fourteen (14) players may be registered to a team.						
2.3.2	<p><b>Player Eligibility</b></p> <ul style="list-style-type: none"> <li>➤ <b>ALL players MUST</b> be a participating, financial member of the Affiliate/club they wish to represent, actively registered player (in the MySideline database), in the current or Previous season, as outlined in <b>Section 2.3.7</b></li> <li>➤ All players must have played in a minimum of five (5) games: <ul style="list-style-type: none"> <li>• In the one team</li> <li>• In the one division</li> <li>• In the one competition</li> <li>• In the same season; and</li> <li>• Within the Affiliate the player wishes to play for.</li> </ul> </li> <li>➤ To be deemed ‘financial’, the player must have no outstanding competition/registration fees within the Affiliated Association, Region and/or QTF.</li> <li>➤ Any player found to be ineligible will: <ul style="list-style-type: none"> <li>• <b>Prior to the Competition</b> – Be removed from the team and unable to compete.</li> <li>• <b>During the Competition</b> – Be removed from the competition and their team may have competition points removed or be disqualified from the competition.</li> <li>• <b>Post Competition</b> – Affiliate, Club, Team Officials, Parents and Players may incur penalties including financial penalty, individual, Team/affiliate/club suspension from future NQ/QTF events, individual suspension from representative selection.</li> </ul> </li> </ul>						
2.3.3	<p>Registration status may be checked for <u>all</u> players and any unregistered players will be unable to participate.</p> <ul style="list-style-type: none"> <li>- The use of unregistered players will result in Championships points’ being forfeited and possible disqualification for that team.</li> <li>- A player may only compete in one division at the JSCN. If a player is found to be playing in two teams, the second team that the player in question has taken the field with will lose all points for any matches that player has participated in.</li> </ul>						
2.3.4	No dispensation will be granted to players who participate with Affiliates/Clubs other than their own, without prior clearance from their registered Affiliate and approved by NQTA.						
2.3.5	Any team taking the field with a player from another Affiliate/Club, who does not have a clearance from the Affiliate/Club that he/she is affiliated with, will forfeit all points for any game that player has participated in for that team prior to receiving a clearance.						
2.3.6	Any combination of clubs and players may nominate, if players and teams satisfy these conditions.

2.3.8	<p><b>Dual Eligibility</b></p> <p>If a player is dual qualified and meets the player eligibility criteria for more than one (1) Affiliate/Club, they are eligible to apply for selection in the Affiliate/Club of their choosing. The player may not nominate for selection at the same time within two Affiliates/Clubs and can only</p>						



	<p>nominate for selection in the second Affiliate/Club if they have been unsuccessful in the original Affiliate. Where the player has trialed for the first Affiliate/Club, the player must request a release in writing from the first Affiliate/Club to the new Affiliate/Club.</p> <p><b>An Affiliate/Club can only deny a player release for the following reasons:</b></p> <ul style="list-style-type: none"> <li>➤ The player has been found to be unfinancial within the Affiliate.</li> <li>➤ The player has unresolved issues relating to misconduct.</li> <li>➤ NQ/QTF have concerns regarding the release.</li> </ul>
<p><b>2.3.9</b></p>	<p>A player is strongly encouraged to play for their Affiliated Association (situated within the geographic area of the regional permit boundaries) in which the players principal place of residence is located.</p>
<p><b>2.3.10</b></p>	<p><b>Player Loan</b></p> <p>The Player Loan process exists to give individuals the opportunity to participate at JSCN where no opportunity exists through their registered Affiliate, however with some safeguards. The following guidelines will be utilised.</p> <p>To be eligible a player must,</p> <ul style="list-style-type: none"> <li>➤ Meet all eligibility requirements in Section 2.3.2</li> <li>➤ Have made themselves available for selection for the Affiliate(s) they are registered with and been unsuccessful in gaining selection; or</li> <li>➤ Their registered Affiliate has not nominated a team in the division they are eligible for</li> </ul> <p>For an Affiliate to loan a player they must,</p> <ul style="list-style-type: none"> <li>➤ Request a release from <b>ALL</b> the Affiliate(s) they are registered with and eligible for.</li> <li>➤ The request must be approved <b>PRIOR</b> to the close of individual player registrations.</li> <li>➤ The player <b>MAY NOT</b> register until the release is approved.</li> <li>➤ The Affiliate must provide <b>ALL</b> approved releases for Player Loans to the NQ Office by the date for close off of the individual player registrations.</li> </ul> <p>Any Player Loan that does not fulfil the requirements listed above will be <b>removed</b> from the Affiliate that wished to loan them <b>without refund</b>.</p> <p><b>An Affiliate lending a Player can only deny a Player release for the following reasons:</b></p> <ul style="list-style-type: none"> <li>➤ The Player did not make themselves available for selection</li> <li>➤ The Player turned down a position offered to them</li> <li>➤ The Player has been found to be unfinancial within the Affiliate</li> <li>➤ The Player has unresolved issues relating to misconduct</li> <li>➤ NQ/QTF have concerns regarding the release.</li> </ul> <p><b>NQ/QTF, in its sole discretion, may approve or block a request for a player loan.</b></p>

To protect the privacy and images, anyone filming games or players will be required to be registered with Tournament Management and have permission to film. In allowing filming they must comply with relevant clauses around the use of the footage, these will be provided on the registration sheet.</li> </ul>

## SECTION 6: APPENDICES

### APPENDIX 1: THE DROP OFF PROCEDURE

#### RULES:

Should a Winner be required in drawn matches; the following Drop-Off procedure is used to determine a Winner as per the 2020 8<sup>th</sup> Edition Touch Football Australia rules.

24.1.1 Each Team will reduce their on-field Team to four (4) players and within 60 seconds take up a position to restart play from the Halfway Line, defending the same end of the field as at the End of Play.

24.1.2 The Drop-Off commences with a Tap from the centre of the Halfway Line by the Team that did not commence the match with Possession.

24.1.3 The Drop-Off will commence with a two (2) minute period of extra time.

24.1.4 Should a Team be leading at the expiration of the two (2) minute period of extra time then that Team will be declared the Winner and Match complete.

24.1.5 Should neither Team be leading at the expiration of two (2) minutes, a signal is given, and the match will pause at the next Touch or Dead Ball. Each Team will then remove another player from the Field of Play.

24.1.6 The Match will recommence immediately after the players have left the field at the same place where it paused (i.e. the Team retains Possession at the designated number of Touches, or at Change of Possession due to some Infringement or the sixth Touch) and the Match will continue until a Try is scored.

24.1.7 There is no time off during the Drop-Off and the clock does not stop at the two (2) minute interval.

24.1.8 Substitution during the Drop-Off is permitted in accordance with normal Interchange Rules.

24.2 Mixed gender Teams may have no more than (2) males on the field during the Drop-Off.

24.2.1 In the case of a male player serving time in the Sin Bin at the commencement of the Drop-Off the offending Team will start with no more than one (1) male on the field.

24.2.2 Where a male player has been dismissed for the remainder of the match, the offending Team will be permitted to have no more than one (1) male on the field for the duration of the Drop-Off.

24.3 At the commencement of the Drop-Off, if there is a player serving time in the Sin Touch Football Australia Playing Rules - 8th Edition 17 Bin and is yet to complete the required time, their Team commences the Drop-Off with one (1) less player on the field than their opposition and continues to play with one (1) player less until the Sin Bin period has been completed.

24.4 At the commencement of the Drop-Off, if a Team has had a player dismissed for the remainder of the match that Team continues to play with one (1) player less than the opposition Team for the duration of the Drop-Off.

24.5 For the avoidance of doubt for clauses 24.3 and 24.4 the non-offending Team will retain a numerical advantage on the Field of Play during the Drop-Off.

#### Abandoned Matches

If a match is abandoned due to any circumstances, the JSCN Tournament Committee shall decide the result.

## APPENDIX 2: CODE OF BEHAVIOUR FOR ALL PARTICIPANTS

*All participants at NQTA tournaments are expected to adhere to the following values and code of ethics.*

### All Participants are to

- Encourage honest and open competition
- Respect individual differences of people within the NQTA
- Support innovation and creativity
- Share failures and celebrate success
- Share the responsibility and work loads
- Participate as members of a team to achieve the Organisation's goals and objectives
- To respect the rights and dignity of other participants
- To not engage in discriminatory or abusive behaviour (especially when children are involved)
- Not to bring the game of Touch into disrepute

### Players

- Play by the rules at all times
- Play equally intensively for yourself and your team
- Be equally loyal to yourself and your team
- Exhibit exemplary sportsmanship at all times
- Enjoy the game by giving your best at all times
- Co-operate with your coach, manager, team-mates, and officials
- Respect your opponents no matter how good or bad they are

### Referees

- Display fairness and uniformity in applying the rules
- Be honest in your assessment of situations
- Be consistent, courteous in calling all infractions
- Condemn the deliberate foul as being unsporting, and promote fair play and appropriate sports behaviour
- Use common sense to ensure the 'spirit of the game' for players is not lost by being too pedantic when applying the rules
- Be conscious that you are seen as a 'Role Model'
- Ensure you remain up to date with any rule changes and / or interpretation of rules as laid down by the Queensland Touch Affiliate
- Make a personal commitment to keep yourself informed of sound officiating principals

### Coaches

- Teach your players that the rules of the game are a mutual agreement which no one should try to evade or deliberately break
- Be reasonable with your demands on players, their time, their energy, and their enthusiasm
- Avoid over playing and / or training your players
- Ensure that equipment and facilities meet safety standards of the age, sex, and ability of your team
- Demonstrate respect for all your players no matter what level of ability they possess. Do not swear or abuse them
- Develop respect for the ability of your opponents, referees, and all officials
- Make a personal commitment to keep informed on sound coaching principals and abreast of current trends
- To encourage good sportsmanship and respect amongst players and opponents
- Distribute a code of behaviour to all participants

### Administrators/Officials

- Ensure that equal opportunity for participation in Touch is available to all regardless of ability, size, shape, set, age, ethnic origin, or disability
- Ensure equipment and facilities are safe and appropriate to the ability level of the participants
- Establish that adequate supervision is provided by qualified and competent coaches and officials capable of developing appropriate sports behaviour and specific skill technique
- Avoid allowing sports programs becoming primarily spectator entertainment. Focus on the needs of the participant rather than the enjoyment of the spectator

- Provide opportunity aimed at improving the standards of coaching and officiating, with an emphasis on appropriate sports behaviour and skill technique
- Ensure all parents, coaches, sponsors administrators, officials, physicians understand their responsibilities regarding fair play in sport
- Ensure on and off the field behaviour is consistent with the principles of good sportsmanship
- Modify rules and regulations to match the skill levels and needs of the players
- Publicly encourage rule changes, which will reinforce the principles of participation and safety
- Distribute a code of behaviour to all participants
- To carry out working with children checks for those who have contact with children

#### **Parents & Spectators**

- Remember that children participate in sport for their enjoyment, not yours
- Encourage children to participate, do not force them
- Focus on your child's efforts and performance rather than whether they win or lose.
- Encourage children to play according to the rules and to settle disagreements without resorting to hostility or violence
- Never ridicule or yell at a child for making a mistake or losing a competition
- Remember that children learn best by example. Appreciate good performance and skilful plays by all participants
- Support all efforts to remove verbal and physical abuse from sporting activities
- Respect officials' decisions and teach children to do likewise
- Show appreciation for volunteer coaches, officials, and administrators. Without them, your child could not participate
- Respect the rights, dignity and worth of every young person regardless of their gender, ability, cultural background, or religion

#### **Pet Free Venue**

- Our Venue is a pet free venue for the safety of Players, Spectators and the general public unless otherwise approved by NQ Touch.

#### **PARTICIPANT CODE OF BEHAVIOUR**

- a- Each team is responsible for players, officials and parents conduct on and off the field throughout the duration of the tournament, travelling to and from the tournament and at team functions and accommodation houses.
- b- Affiliates/clubs are to ensure that all team officials, players, and parents are made aware of the full Code of Behaviour expected from players, officials and parents attending the Championships. Copies of the Code of Behaviour will be forwarded to all Affiliates/clubs participating in the Championships.
- c- Consistent breaches of the Code of Behaviour by any individual may result, in the case of a player or players, being suspend for the duration of the championships and, in the case of an official or parent, being asked to leave the Queens Park area.
- d- Due to safety reasons for both spectators and players No spectators will be allowed to stand or sit along the side lines between Fields 1 & 2, Fields 3 & 5, Fields 4 & 6, Fields 5 & 7 and Fields 6 & 8. (See program for diagram)
  - ii -- No spectators are permitted in the sub-box area. Players, coaches, and team managers ONLY.

#### **APPENDIX 3: NQTA BLOOD BIN POLICY**

- 1) Any player with a bleeding cut or abrasion is to leave the field immediately and have the cut or abrasion cleaned or covered. At this time any blood-stained clothing must be either cleaned or replaced.
- 2) If the player does not leave the field immediately, the Referee **must** stop the game and ask the player to leave the field. (Normal substitution rules apply).
- 3) Once the flow of blood has been stemmed, the cut or abrasion cleaned and covered and any blood-stained clothing and equipment cleaned or **replaced**, the player may return to the field and continue play.
- 4) If bleeding cannot be controlled and the wound securely covered, the player **must not continue in the game**.
- 5) All open cuts and abrasions must be reported and treated immediately.

#### **APPENDIX 4: CONCUSSION POLICY**

A concussion is defined as a disturbance in brain function caused by direct or indirect force to the head, face, neck or elsewhere with force transmitted to the head. TFAs current concussion policy was developed based on the latest findings from the '2017 Concussion in Sport Group consensus statement and the Sports Medicine Australia Concussion in Sport Policy'.

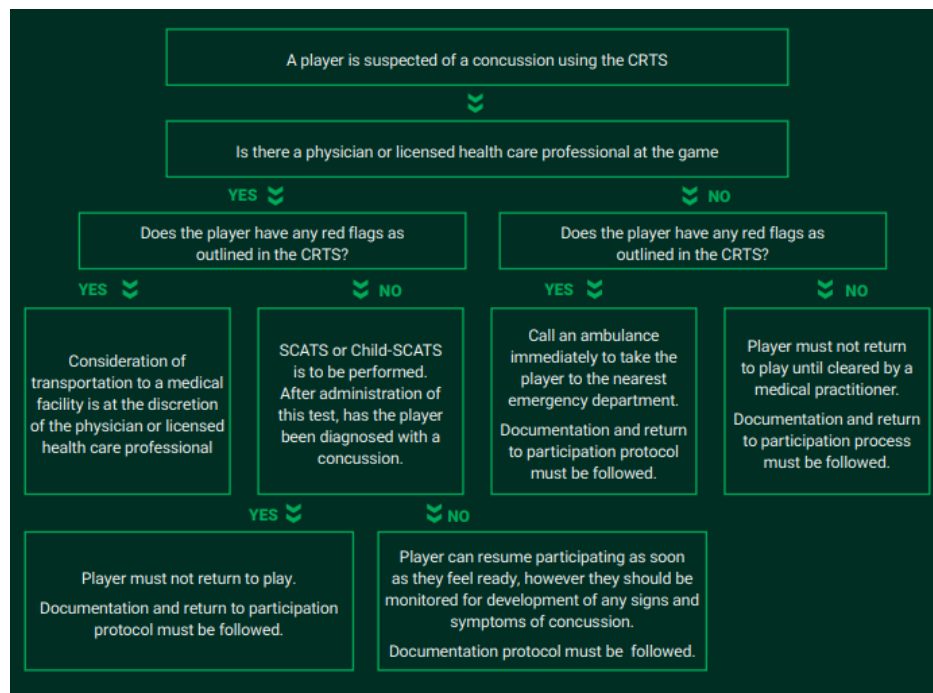
The aim of these guidelines is to ensure that all players with a suspected concussion receive timely and appropriate advice and care to safely return them to activities and sport. It will outline the process that must be followed to:

- Recognise an athlete with a suspected concussion or red flags
- Manage a suspected concussion or red flags
- Manage return to participation after concussion
- Document/report a concussion
- Communicate information effectively to the athlete regarding concussion, monitoring and return to sport process
